Course open to all Honors students (not just economics majors) and others who are highly aspiring. The only formal course requirement is that you have taken *one* of the following courses: Econ 20A, Econ 20B, or Econ/IS13

Course description: Political Economy seeks to understand the interaction of economics and politics. The course will examine topics such as the following: externalities and public goods; the role of government in the economy; lobbying and money in politics; causes of the Great Recession; the nature and the role of nation-state in the economics. (The particular topics that will be covered will be partly determined by the interests of the students in the class.) The course will be combining both lectures and class discussion. Students will be doing readings in advance and student participation will be encouraged. The format of the course will be facilitated by the small number of students and will try to emulate the experience of similar courses in liberal arts colleges.

Expectations from students: Before class, email a question about the reading that you would like answered, participate to the extent possible in class discussion; a choice between a presentation/take-home-exam and a paper towards the end of the course.
